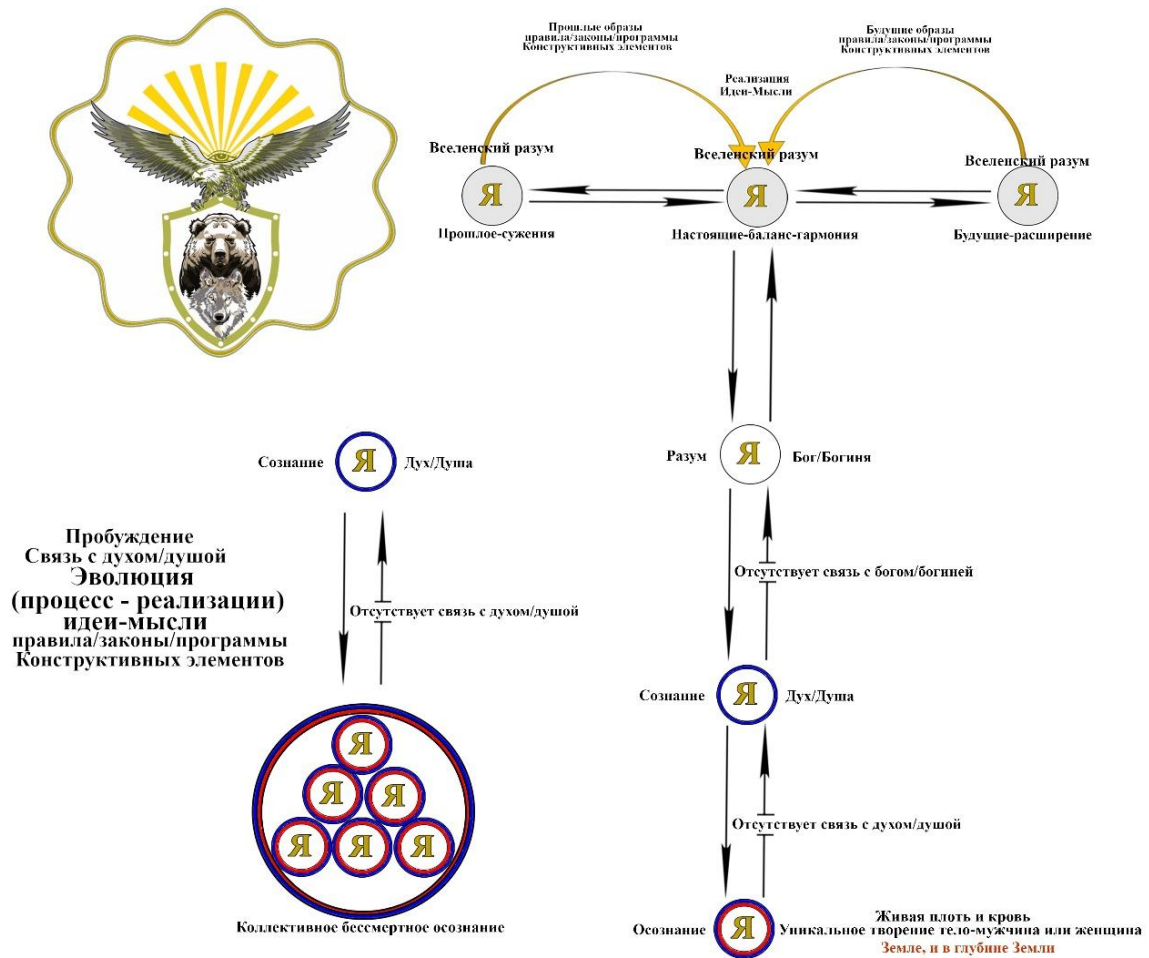

**"Only you create everything and set the rules in antimatter, which are then projected into matter"**

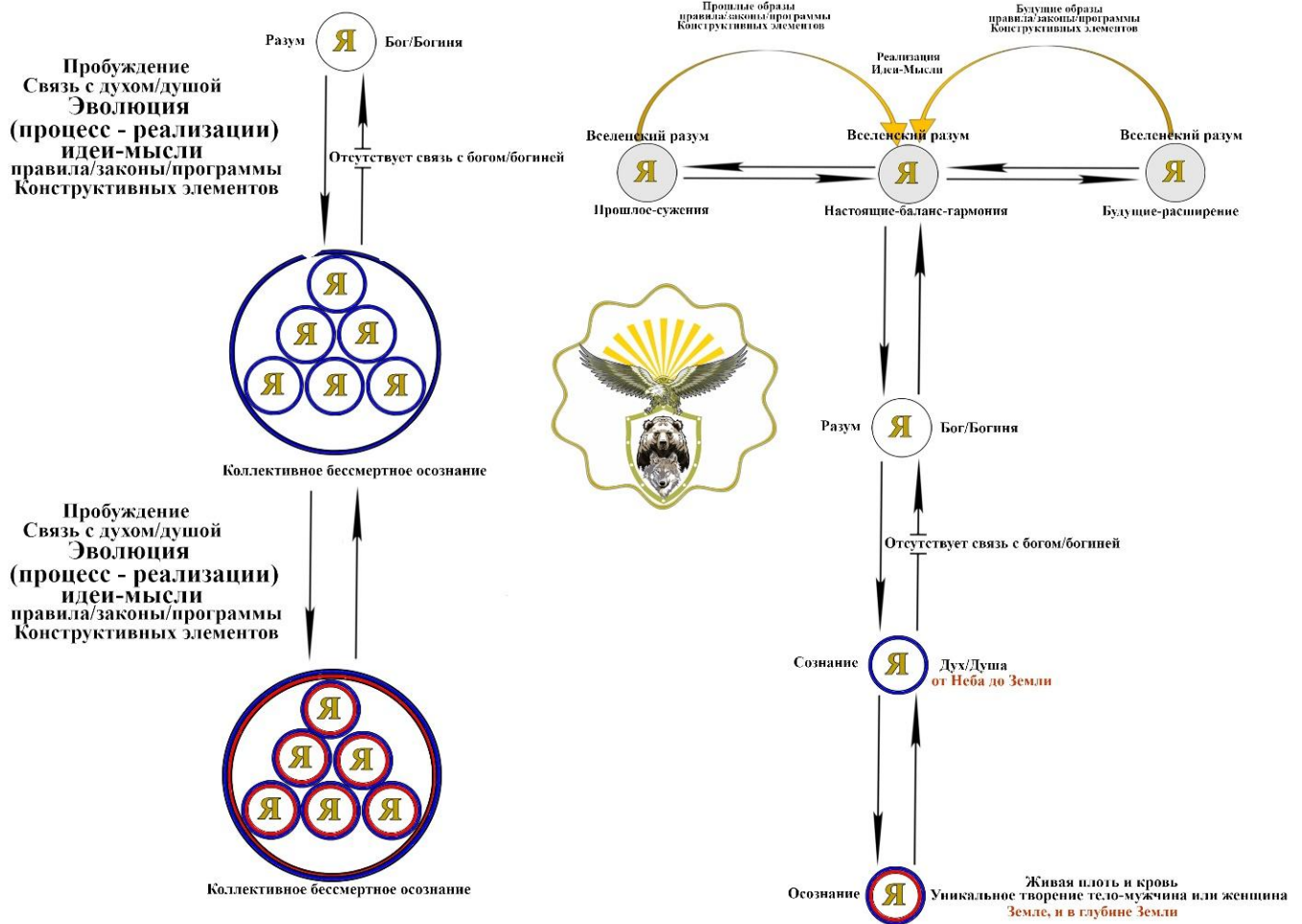
Man or Woman is the creation itself, - Awareness (conscious thinking) is the process of understanding that you are more than paper or a thing.

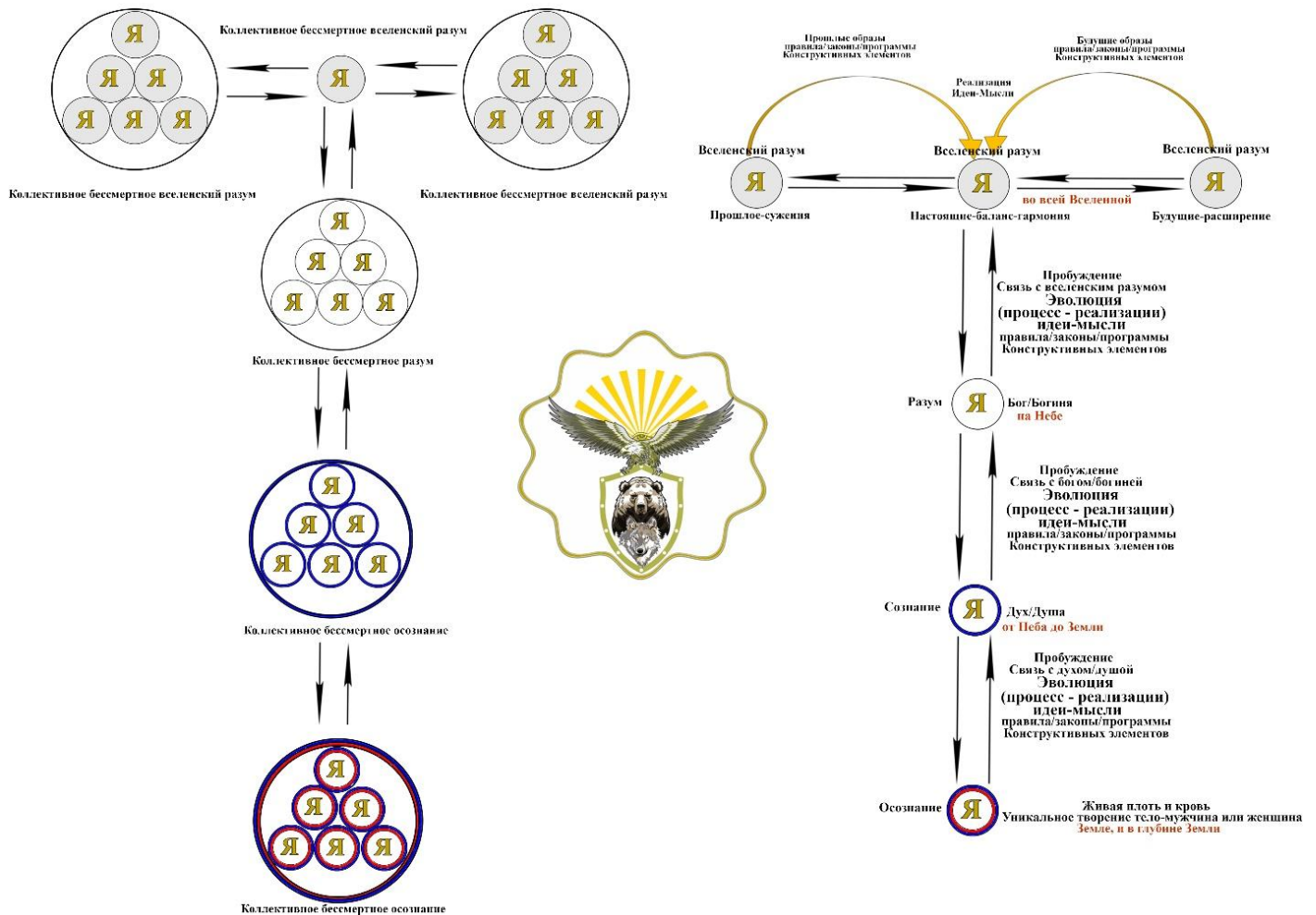


Spirit or Soul - the control of creation, - Consciousness (conscious thinking) - is the process of understanding that you are more than a man or a woman, than a slave or a beast.

## **LIST OF TERMS**

This document contains the following terms: "**Absolute Truth**"

"**Acceptance**" means evidence by express consent in the case of an Agreement or implied consent in the case of a Contract that the offer has been accepted by all parties. In the absence of any reasonable argument in favor of the existence of consent (acceptance), the agreement or contract cannot be defined as having legal or enforceable force;

"**Acceptor**" means the payer who has accepted the draft or other document;

"**Accounts**" means all records of our assets, other than bank accounts, which are kept in the office of our assets;

**"Accounting Standards"** means:

- a. Generally accepted accounting principles that are present and consistent with the major standards of foreign countries, companies and corporate entities relating to the preparation and content of financial statements and accounts;
- b. The accounting principles, rules and practices adopted by our company, its trusts and subsidiaries in the preparation and maintenance of financial statements and accounts based on the same consistent standards of foreign countries, companies and corporate entities;

**"Accounting Period"** means the standard measure and period for the preparation of accounts, expressed as a solar year of 365 days; or expressed as Gregorian time of 365 days;

**"Claim"** means an action for compensation, a claim, a counterclaim, a set-off and any other proceeding in which the right of one of the parties is determined in a court of competent jurisdiction;

**"Counterclaim"** is a claim that seeks to extinguish a plaintiff's property interest in an asset and in which the plaintiff must prove that it is an infringement of the plaintiff's right to possess, transfer or deal in the asset of another;

**"Bill of Lading"** means a document evidencing receipt of goods for shipment, issued by a Self-aware biological life form of a higher order engaged in the transportation or forwarding of goods;

**"Body"** means the biological component of the Self-conscious life form of the highest order and the physical servant of the enlightened mind;

**"Body Corporate"** means the single body of property, rights and uses of a Trust created by law, also known as the Trust Body. A Body Corporate is most commonly known as a corporation or person;

**"Bond"** means Securities;

**"Registration Entry"** means a bond or similar security for which no certificate is issued but the title granted thereunder is registered in an existing register, ledger or roll;

**"Purchaser"** means a Self-aware higher order life form or person who makes one (1) or more purchases from a seller of goods or services;

**"Canon"** , also **"Canons"** , means **Astrum Iuris Divini Canonum** ;

**"Cancellation"** means notice of a desire to terminate an activity before the end of a contract;

**"Cap"** is the traditional abbreviation for **Capitulum** ;

**"Chapter"** means an important part or section of an official document, a chapter or paragraph used in accordance with tradition and custom in distinguishing between statutes and decrees, especially by adding amendments to a previously existing statute;

**"Charter/Statute of the Vorobyov Family"** means the highest of all charters, agreements, acts and treaties for the planet Earth and the entire Solar System;

**"Certificate of Deposit"** means a document containing a bank's confirmation that the bank has received a sum of money and the bank's promise to repay that sum. A certificate of deposit is a bank's promissory note bearing interest and due on a specified date;

**"Certified collateral (security)"** means collateral (security) that is certified by a certificate;

**"Chancellor"** means the rector and senior notary scribe responsible for the safekeeping of all documents, securities and negotiable instruments issued for and on behalf of our estate, kept in the chancery;

**"Chancery"** means the secure repository and archives of our estate, for the safe keeping of the original scriptura (official documents) and other important manuscripts and the register associated with them, as well as all records of our estate, excluding bank accounts;

**"Charter"** means a form of contract or deed in the form of a patent granting any form of right or use, in accordance with the contents of a map, plan or cadastral register;

**"Church"** means a type of religious institution consisting of one or more congregations of believers who have a specific sanctuary and place of worship and whose spiritual education and training are entrusted to a duly appointed priest, clergy, or minister;

**"Child"** means a person, including an infant or minor, who may be considered a ward under this document;

**"Limited flesh"** means an Initiate;

**"Plaintiff"** is the person seeking recognition of property rights or assets;

**"Clerk"** means an administrative assistant with special powers attached to the Apostolic Mendicant Minister;

**"Record Keeper"** is a position to which the Chief Executive appoints a Self-aware life form of a higher order who must, under oath, create and maintain all records of our property;

**"Claim"** means any formal demand or cause of action for ownership, compensation or damages where certain key elements are alleged to have sufficient weight to establish a right, either in favour of or against an asset(s) or liability of our estate, a trust or a subsidiary of our estate;

**"Claim of Right"** is the right to control our property, which includes, but is not limited to, our primary land asset, our biological property, granted in exchange for our pledge of allegiance to the Divine Creator and Maker;

**"Codicil"** means a written addendum or appendix to a Testament which amends the document and must meet the same requirements as those required for probate of a will;

**"Commercial unit"** means a unit of goods which, by virtue of commercial use, constitutes a complex instrument for the purpose of carrying out a sale and the division of which substantially impairs its quality or value on the market or in use. A commercial unit may be a single article (such as a machine) or a set of articles (such as a set of furniture or an assortment of sizes) or a quantity (such as a bale, gross or wagon) or any other unit considered in use or on the relevant market as a single whole;

**"Communication"** means the concept or state of exchange of significant information between entities. It also represents the message and the essential information conveyed in the act of communication;

**"Agreement"** means a harmonious state of the whole and congruence of the parts with each other and with the whole; as well as a meeting of minds;

**"Initiate"** means a person declared and designated as an initiate;

**"Consent"** means an expressed agreement with something proposed; consent cannot be implied by silence;

**"Consideration"** is the communication of information about the value of an item given as a means to reach a consensus;

**"Concept"** means a general notion or idea, a directly perceived or contemplated object of thought, something that can be described by two (2) or more separate observers as evidence of the correctness of their understanding, but whose existence (the concept) depends on the methods by which observers name and classify it;

**"Consensus"** means a term describing an agreement between various parties with respect to one (1) or more acts relating to certain property or rights;

**"Custodian"** means a person appointed by the court or the general executor and guardian to manage the affairs of another person, in accordance with this document;

**"Copyhold"** means the use of property, equitable title, benefit, or privilege of a person, as distinct from a Self-aware biological life form of a higher order, existing by virtue of any entry or recording in a ledger, register, or Great Roll (Estate Roll) granted by a government, state, or Lord and kept according to the customs of the estate. Copyhold is granted for many years or for life. A copy or extract from the register is given to the holder of the copyhold as evidence of their right. Thus the term **"Copy (copy) gold (holder)" is derived ;**

**"Copyright"** means a lease created by granting ownership of a copyright by agreement or by presumption of waiver of past, present or future claims to the copyright. Thus, copyright is a lower category than copyhold. Thus, copyright protection (all rights reserved) for an unregistered original work is in effect a claim to a lease, by granting ownership derived from some anticipated future copyright to be created by the registration and assignment of higher rights. A person cannot claim both copyright and copyhold;

**"Corporation"** literally means "an association of one or more persons exercising funeral rights related to the burial rituals of dead bodies"; (commentary - Corporation: Corpse - corpse; ratio-relationship; proportion)

**"Sole Corporation"** means the charitable foundation of Sergei Nikolaevich of the Vorobyov family, General Minister of the Church Sergei Vorobyov (General Minister). The Sole Corporation is fundamentally different from the spiritual General Minister of the estate of Sergei Vorobyov. The duly appointed General Minister is defined in civil law as **"The Vorobyov Family Charitable Foundation, Sole Corporation"** ;

**"Court"** means a legal or administrative proceeding within the jurisdiction of the laws of our estate and the powers of the executor general and guardian or appointed agent in a dispute concerning the affairs of our estate, the conduct of an officer or any claim brought against the property of our estate. In relation to other courts - **"International Court"** ;

- a. **An unsecured creditor** is a party who does not have a legal right to claim some or all of the remaining assets of an estate, trust, or subsidiary;



- b. **A secured creditor** is a party who has, by judgment, instrument, or other official document, a legal right to claim priority for payment from the remaining assets of an estate, trust, or subsidiary over all other types of creditors other than secured creditors;
- c. **A security interest creditor** is a party who holds, by judgment, instrument, or other official device, a lien claiming the highest priority from among the remaining assets of an estate, trust, or subsidiary;

**"Debt"** , also **"debts"** , means any outstanding financial obligation, claim or encumbrance on our property, the Trust or a subsidiary of our property;

**"Deed"** - from 14th century Old English daed/deed and 14th century German daedis, meaning *"a written legal document that grants a right with evidence or through which a right is waived with evidence ."* From the 15th century onwards, the additional legal meaning of "a legal contract relating to bondage" was added. By the 17th century, the word had become further confused with the meaning of "a deed done";

**"Defendant"** means the party responding to (defendant from) a claim, counterclaim, cross-claim, or third-party claim;

**"Surrender (Transfer)"** - in relation to a document, title document or movable property - means the voluntary transfer of ownership;

**"Derivative instrument"** , also **"derivative instruments"** , means an object, concept, notion, document or negotiable instrument derived from another, created by any process or ritual in accordance with any form of law or custom. A derivative owes its existence to the prior existence of something else;

**"Descendant"** and also **"descendants"** means the Beneficiary;

**"Possession"** means the right to dispose of real and personal property by will and to manage it;

**"Owner"** means any person appointed by this instrument to exercise the right of ownership. In the case of a transfer of such right to an existing trust or trustee in a trust as defined herein, then the trust or trustee is the owner and the beneficiaries are not owners;

**"Discrimination"** means the ability to detect, perceive, recognize or comprehend certain things within or without, using the intellect. Discrimination can be defined as general or supreme:

- a. **General discrimination** is the ability to detect, perceive, recognize, or understand specific objects, life forms, situations, or information internally or externally;
- b. **Higher discrimination** is the ability to detect, perceive, recognize or understand certain non-physical, esoteric, academic and fictitious constructs or arguments internally or externally;

**"Impairment of a letter of credit"** means the failure to recognize in a timely manner or to take provisional measures, such as a draft, that may be required in connection with a letter of credit;

**"To dispose of"** , also **"to dispose of"** , means:

- a. **Sell** , transfer, assign or otherwise dispose of or deal with any property of our estate, trust or subsidiary of our estate;

- b. **Agree** , offer or grant any option that, if exercised, would permit a person to sell, transfer, assign or otherwise dispose of or deal with any property of our estate, trust or subsidiary of our estate;
- c. **Create** , agree or propose to create a security interest in, hold yourself out as a trustee for, or share in the profits of, any property of our estate, trust or subsidiary of our estate;
- d. **Alienate** any right or legal, beneficial or equitable interest or right in or to that property (or any interest in it or any part of it), whether done before, during or after the person obtained any interest in that property;

**"Distributor"** means any person who receives the property of our estate through a personal representative, but not through the agency of a creditor or purchaser. A testamentary trustee is distributable only to the extent that the assets to be distributed or the accrual thereto remain in his hands;

**"Divine"** means any right of ownership, gift or grant from the Divine Creator and Maker;

**"Divine Creator and Maker"** means the only true Divine Creator and Maker and owner of all that exists, who is omnipotent, Alpha and Omega;

**"Divine Commission"** means an official assignment to perform specific tasks and missions for and on behalf of the Divine Creator and Maker;

**"Divine grace"** means the spiritual presence or personification of the Divine Creator and Maker during a particular action or event;

**"Holy Spirit or Divine Immortal Spirit"** means a unit of collective immortal consciousness;

**"Divine Law"** means the law that defines the Divine according to the Astrum Iuris Divini Canonum and clearly demonstrates the dream, spirit, intelligence, purpose and direction of the Divine Creator and Maker, including the operation of the will and power of the Divine Creator and Maker through existence. Therefore, it can be said that all valid laws originate from the Divine Law. Therefore, the highest law of all laws is the Divine Law, then the Spiritual, the Natural/Cognitive/Natural Law, then the Positive Law.

**"Divine will"** means Divine Testament;

**"Document"** , also **"documents"** , means a conventional form of spiritual or temporary written instrument consisting of one (1) or more pages, each of which has an obverse or front side and a reverse or back side. There are only five (5) valid forms of documents: Supreme, High, Middle, Ordinary and Inferior:

- a. **A supreme document** is a valid document, issued and sealed by the supreme official, registered in the Great Register and public annals of the Estate, and existing, firstly, as a supreme spiritual and ecclesiastical instrument, and secondly, as a supreme secular ecclesiastical instrument, possessing an absolutely living personality. There is nothing higher and more powerful than a supreme document;
- b. **The Supreme Document** is a valid document issued and sealed by the highest official, registered in the Great Register and the public chronicle of the Estate and existing, firstly, as the highest spiritual and ecclesiastical instrument, and secondly, as the highest secular

ecclesiastical instrument, possessing an absolutely living personality. This is the second most important and powerful document;

- c. **A medium document** is a valid document, issued and sealed by a medium official, registered in the Great Register and public annals of the Estate, and existing first as a medium spiritual and ecclesiastical instrument, and secondly as a medium temporal ecclesiastical instrument, possessing a full living personality. It is the third most important and powerful document of all;
- d. **An ordinary document** is a valid document issued and registered in the Great Register and public record of the Estate, which is not issued by an ordinary, senior or supreme official;
- e. **An inferior document** is any document issued by an inferior person, such as a Roman person or an inferior legal person. No inferior document can claim precedence over a common document, a middle document, a superior document, or a supreme document;

**"Document of title"** includes a bill of lading, dock order, dock receipt, warehouse receipt or order for the delivery of goods; and any other document which in the ordinary course of business or finance is regarded as adequate evidence that the Person in whose possession it is has the right to receive, keep and dispose of the document and the goods covered by it. A document of title must be issued to or addressed to an authorized person and must cover goods in the possession of that person which are either identified or are fungible parts of a specified mass;

**"Draft"** , also **"Drafts"** , - Negotiable instruments;

**"Project"** is a check;

**"Payer"** means the person to whom the check instructs to make payment,

**"Drawer"** means the person who issues the check (receipt, payment order);

**"Duties"** means the specific obligations arising from the fiduciary duties of one's position;

**"Ecclesiastical"** means relating to religion, especially in a church;

**"Electronic"** means relating to technology that has electrical, digital, magnetic, wireless, optical, electromagnetic or similar capabilities;

**"Electronic Agent"** means a computer program or electronic or other automated means used independently to initiate an action or respond to electronic records or performances, in whole or in part, without the participation or action of an individual;

**"Electronic Record"** means a record created, generated, sent, communicated, received or stored by electronic means;

**"The Estate"** means all known and unknown property of Sergei Nikolaevich of the Vorobyov clan, also known as Sergei Vorobyov, and all variations thereof defining claims to ownership with absolute power, including all money, land, all buildings and animals over which the Self-aware biological life form of the highest order has absolute power in exchange for an oath of allegiance to the Divine Creator and Maker;

**"Executive Government"** - consists of a group of self-aware, higher-order life forms, appointed or elected, that administer public policy at the highest level in a particular political jurisdiction;

**"Executor"** means one (1) or more Self-aware life forms of a higher order that govern our lives. And **"executor"**, also **"executors"**, means an executive administrator appointed by either a testator or a trustee;

**"Executor of untruth (French desontort)"** means a person who acts as executor of our estate without any legal warrant or authority granted by the Principal Executor and Guardian, but who, having entered upon the office, is liable and therefore liable to punishment for wrongful acts;

**"Exempt Property"** means that property of our estate which is exempt from claims, duties, taxes, or other penalties or demands of a foreign estate or foreign court;

**"False doctrine"** also **"heresy"** means any and all doctrines, dogmas, beliefs, assertions, edicts and laws that are contrary to the Divine Will and Divine Law, including but not limited to such false concepts as Original Sin (Peccatum Originale) or the Prison of the Mind/Matrix of Madness (In Mundi);

**"Fault"** means a failure to perform, breach, or wrongful act or omission;

**"Fidelity"** means fidelity and devotion to the obligations of honorable management; the rights of use, otherwise known as property;

**"Fiduciary"** and **"Fiduciaries"** are persons who have assumed certain obligations upon appointment to office, including, but not limited to, a personal representative, guardian, custodian and trustee appointed in accordance with this document;

**"Financial document"** means a bill or other claim, title deed, investment security, certificate, invoice or other record, statement or representation of fact, law, right or opinion.

- a. Which is presented in writing or in such other form as is permitted by the credit, or, if not prohibited by the credit;
- b. Which can be verified for compliance with the terms of the letter of credit, the document cannot be oral;

**"Foreign Court"** means a legal or administrative proceeding under the jurisdiction of a foreign country which claims or implies jurisdiction over any controversy relating to the affairs of our country, the conduct of an official, or any action brought against an estate of our country;

**"Foreign Exchange Transaction"** means a transaction in which one (1) party agrees to deliver a specified amount of money or unit of account subject to the agreement of the other party to deliver another amount of money or unit of account either now or in the future, and in which delivery is to be effected by means of a funds transfer, an accounting or other form of payment order, or other agreed means for transferring a credit balance. This term includes a transaction of this type involving two (2) or more instruments, as well as spot, forward, option or other derivative products on underlying instruments, and any combination of these transactions. This term does not include a transaction involving two (2) or more instruments in which one (1) or both parties are obligated to make physical delivery, either at the time of contract formation or in the future, of banknotes, coins or other form of legal tender or currency;

**"Foreign Government"** means the manager of a foreign real estate, company or corporation, and its subsidiaries, whether elected or not;

**"Foreign Jurisdiction"** means a jurisdiction that is not governed by our property, that does not have direct jurisdiction over our property or its subsidiaries;

**"Foreign Person"** means a person who is not ordinarily subject to the jurisdiction of our estate, unless by engaging in the affairs of our estate through trade, bonds or commerce they elect to submit to its jurisdiction;

**"Foreign Personal Representative"** means a personal representative appointed by another jurisdiction;

**"Form"** means the shape, appearance and properties of an object or concept attributed by a certain action or ritual according to AstrumIurisDiviniCanonum. Form is never the object or concept itself, but the meaning and properties attributed to the object or concept by a certain action or ritual. Therefore, all forms are fictitious. There are seven (7) real forms: being, man, species, animal, plant, concept and thing;

**"Official Proceedings"** means any proceeding conducted by a court presided over by a person duly appointed as agent and judge and with notice to the persons concerned;

**"Freedom"** means responsibility for a previously made decision;

**"Power"** means freedom of choice and decision making.

**"Frugality"** means the qualities and character of prudence, thrift and economy in the use of property and resources to minimize losses. To use only what is necessary, as opposed to gross wastefulness and sybaritism;

**"Full disclosure"** means the obligation to disclose any and all material facts before entering into a contract or agreement;

**"Money Transfer"** means the transfer of funds from one party to another;

**"Substitute goods"** means goods any unit of which is by its nature or use in trade equivalent to any other unit of the same kind; or goods which are by agreement regarded as equivalent;

**"Newspaper"** means an official document containing legal and governmental public notices, which is a printed publication having a nominal value equivalent to the lowest value of currency;

**"General Executor"** is a term used to designate the Self-conscious life form of the highest order who is the supreme representative of authority in our estate and is the highest level and source of official authority in any valid system of law based on trust. The power and authority of the office of General Executor is called Dominium, possession or dominion;

**"Genuine"** means the opposite of counterfeit;

**"Gift"** means the transfer of title and ownership of any good, property, right or right of use to another person voluntarily, free of charge or in exchange for any commercial or business purpose;

**"Good faith"** and **"in full confidence (BonaFide)"** means true honesty and compliance with reasonable standards of fair dealing;

**"Commodity"** means a present or future concept held in trust, defined as useful and therefore possessing value measured by some unit of value that can be transferred from hand to hand, at the moment of sale. Since a good is a form of a concept, the actual good may be either material (the object) or immaterial (the concept). Any law, regulation or decree that subdivides the class of "rational man (Homo Sapiens)" into a lesser class as a form of commodity is a direct affront to the laws of the Divine Creator and Maker and is therefore automatically invalid from the outset;

**"Great Charter/Statute"** means the Great Charter created by our will, a document representing the highest of the official documents both in power and in the governance of our class/family;

**"Grant"** also means a conditional and temporary transfer of title and ownership of any good, property, right or right of use to another person voluntarily and free of charge;

**"Grantor"** means the grantor of a title to property transferred to our Estate or the Estate Trust;

**"Great Register"** means any valid register of an estate, as distinguished from the register of a smaller entity;

**"The Great Register and Public Chronicle of the Estate"** also **"The Great Book of Souls"** also **"The Great Book of Life"** - means: the supreme and highest register of the Family;

**"Great Seal"** - The Great Seal is the second highest seal possible and is the official seal of any corporate body corporate or public body corporate. Therefore, the Great Seal is used to authenticate documents of the highest importance issued on behalf of a universal true trust, a global true trust or a civil true trust;

**"Governing Document"** means this Document (Will and Testament);

**"Government"** means the Self-conscious life forms of higher order that govern the estate;

**"Guardian"** means a position established by a Self-aware biological life form of a higher order, including Reason. A Guardian is appointed by order or patent by the General Executor and a Guardian who has qualified as a guardian or trustee of a minor or incapacitated person in accordance with the procedure established by this document or by an administrative court decision;

**"Guardian in lie (French desontort)"** means a person who assumes the duties of guardian of our property without any valid order or patent issued by the general executor and guardian, but who, by his appointment to the office, makes himself liable and therefore subject to punitive actions;

**"Head of State"** means the General Executor and Guardian of our Estate as Sovereign over all property known and undiscovered;

**"Heir"** , also **"heirs"** , also **"A posteriors"** , means a Self-aware biological life form of a higher order or a man or woman, not named herein, who by virtue of kinship, is customarily entitled to certain hereditary property, rights, or use of our property. Heirs are also known as posterity;

**"Self-conscious biological life form of a higher order "** , as well as **"Self-conscious life form"** - means the highest level of life and particles of collective immortal consciousness and conscious thinking;



**"Holder"** means:

- a. a person in whose possession is a negotiable instrument payable either to the bearer or to an identified person in whose possession such instrument is;
- b. the person in whose possession the document of title is, if the goods are delivered either to the bearer or by order of the person in whose possession they are;

**"Holy Scripture"** means Scripture;

**"Honor under a letter of credit"** means the issuer's performance of the obligation under the letter of credit with respect to payment and delivery of the valuable commodity. Unless the letter of credit provides otherwise, "honor" takes place:

- a. after payment has been made,
- b. if the letter of credit provides for acceptance, then upon acceptance of the latter and upon the maturity of its payment,
- c. if the letter of credit provides for the emergence of a deferred obligation, then after the acceptance of the obligation and its fulfillment upon the maturity date;

**"Man"** , also **"monster"** , means an animal attached to the Earth;

**"The enlightened mind"** means the mind that has consciousness, knowledge, intelligence, reason, insight and wisdom in the study of the humanities and the nature of man, who has also realized himself as *"living in the world as an integral part of it, and not existing separately from the world ."* Therefore, the enlightened mind is Homo sapiens, a rational being and a product of reason, in contrast to those who, according to the custom of Western Roman law, are variously described as animals (creatures);

**"Income"** means cash receipts into our Family Estate or any trust or subsidiary of our Family Estate from interest earned on capital investments, or income derived from the existence of any profit after taking into account receipts and payments, or income derived from the business or personal activities of one (1) or more persons, if such persons or activities are registered or regulated by our Family Estate or a foreign jurisdiction;

**"Incapacitated Person"** means a legal fiction attributed to an injured or disabled Self-conscious biological life form of a higher order;

**"Individual"** means We;

**"Endorsement"** means a signature made, alone or in the context of the contents, on a security or bond, or on a separate document for the purpose of appropriating, transferring or redeeming the value of the security or of giving authority to appropriate, transfer or redeem it;

**"Informal Proceeding"** means a proceeding conducted without notice to the persons concerned by an officer of the court of our Estate-Family;

**"In Mundi"** , also **"The Underworld"** , also **"The Matrix of Madness"** , also **"Hell on Earth"** , a cult false heritage concept for the maintenance of fear and control, means that humanity is condemned to a period of life on Earth and will atone for its guilt and be tested as if it were between worlds, like Dionysus or Persephone in the 4th century BCE in the Orphic Greek Mysteries, like Bacchus in the Elysian Roman Mysteries. Contrary to false definitions, Mundus

(Mundi) was equivalent in the Elysian doctrines to the concept of Tainaros mentioned in the Orphic doctrines, while Inferno (hell) in Latin was equivalent to Tapgog (Tarsos) in Greek;

**"Insolvent"** - having ceased to pay obligations in the ordinary course of business, in all cases except as a result of a bona fide dispute

- unable to pay debts as they fall due;
- being insolvent within the meaning of the Federal Bankruptcy Law;

**"Insolvency (bankruptcy) proceedings"** means an assignment in favor of creditors or other proceedings aimed at liquidation or restoration of the property mass of the relevant person;

**"Intention"** means the mental activity of the mind caused by an underlying desire, intention, purpose or meaning, which is the will, which leads to further mental impulses and/or physical actions. Since intention or purpose is caused by the will, but is the source of any subsequent action or further mental impulse, intention can be considered as planning, calculation and the higher cognitive phases of thought (Analysis, Synthesis, Evaluation, Metacognition) leading to some result;

- a. **Analysis** - The ability to break down information into its components and identify relationships and patterns. This includes critical thinking and data evaluation.
- b. **Synthesis** is the process of combining disparate pieces of information to create a new, coherent concept or idea. It is an important aspect of creative thinking.
- c. **Evaluation** - The ability to judge the value of information or ideas based on specific criteria. This may involve making decisions and forming judgments.
- d. **Metacognition** —Awareness and control over your own cognitive processes. This includes the ability to analyze how you learn and think and adjust your strategies.

**"Intestacy"** means the absence of a valid will;

**"Intelligence"** , also **"understanding"** , means the powers of judgment, abstraction, reasoning, discrimination and conceptual understanding of the internal, external and other dimensions. The word "intelligence" also defines these powers collectively as the object itself and the man or woman who possesses such powers in a higher degree. The twelve (12) primary powers of intelligence are sensualism, athleticism, mathematicalism, pragmatism, collaborationism, altruism, abstractionism, conceptualism, hierarchism, grammarism, constructivism and illusionism;

- a. **Sensitization** is the intelligence that enables one to use one's senses to gain more information and empathy from the environment and other people;
- b. **Athleticism** is a proprioceptive (kinesthetic sense) intelligence in which a person has a high ability to sense and move the appropriate parts of the body in sometimes complex technical movements;
- c. **Mathematics** is an intelligence that includes mathematical competence and the ability to solve problems of varying degrees of complexity;
- d. **Pragmatism** is the intelligence and ability to effectively implement decisions and take actions that are useful in practice, not just in theory;

- e. **Collaboration** is the ability to work with others and enable them to use their skills to the best of their ability;
- f. **Altruism** is the intelligence of helping, protecting, and meeting the needs of others through ideas, patterns, and actions superior to one's own;
- g. **Abstractionism** is the intelligence of observation, analysis and problem solving associated with complex forms.
- h. **Conceptualism** is the intelligence that enables one to conceptualize complex environments, images, and interactions.
- i. **Hierarchy** is the intelligence of information process and analysis to create ordered architectures based on hierarchies and classifications, such as systems of logic and ordered arguments;
- j. **Grammar** is the intelligence of using language form, rules, and usages to communicate effectively with other members of a species;
- k. **Constructivism** is the intelligence of deconstructing or constructing a series of steps or actions and the ability to repeat such steps with high fidelity.
- l. **Illusionism** is the intelligence that allows one to bring creative inspiration to life, as well as the ability to imitate other people, settings and environments.

**"Interested Person"** means: inventors, children, spouses, creditors, beneficiaries and any other persons having property in or a claim against our estate or our estate trust. It also includes persons having priority for appointment as personal representative and other fiduciaries representing interested persons;

**"Document"** means an actual document and, unless otherwise specified, means a document having a particular legal form such as a deed, pact, charter, patent, treaty, contract, order or warrant;

**"Issuer"** means the bank or other person who issues the credit, but does not include an individual who enters into the obligation for personal, family or household purposes;

**"Joint tenants with right of survivorship"** and **"community tenancy with right of survivorship"** include joint tenants of property held under circumstances giving one (1) or more persons a right to the entire property upon the death of the other or others, but excludes forms of joint tenancy in which each party's primary title is in proportion to that party's contribution;

**"Jurisdiction"** means the primary jurisdiction of law to govern our estate;

**"Justice"** - means Astrum Iuris Divini Canonum, known as the living body of Canonical Divine Law, consists of four books;

**"Earth"** - means the soil, the surface of the Earth, and also the highest level of Self-conscious biological life forms (God the Creator and Maker created man and woman on the earth and from the earth and gave them a name);

**"Law"** means the legal order, norms, laws and policies that regulate competences in accordance with the sacred covenant and Canonical Divine Law and codes of law;

**"Legal representative"** - includes a representative of a payee, a guardian or a conservator acting on behalf of the defendant hereunder and under the Estate or elsewhere, in the capacity of trustee or custodian of a trust or trusteeship of which the defendant is a beneficiary, and an agent appointed under a power of attorney, whether for health care or property, in which the defendant is identified as the principal;

**"Lease"** means the transfer of the right of possession and use of goods for a fixed term in exchange for consideration, but a sale, including an agreed assignment or transfer, or the reversion, retention or creation of a security interest, is not a lease. Unless the context clearly indicates otherwise, the term includes a sublease;

**"Leaseholder"** means the person who acquires the right of possession and use of goods under a lease. Unless the context clearly indicates otherwise, the term includes sublease;

**"Lessor"** means the person who transfers the right of possession and use of goods under a lease. Unless the context clearly indicates otherwise, the term includes sublease;

**"Letters"** - includes letters testamentary, letters of guardianship, letters of administration and letters of trusteeship;

**"Letter of Credit"** means a specific undertaking which satisfies the requirement of the issuer to the beneficiary, at the request or expense of the applicant or, in the case of a financial institution, to itself or at its own expense, to make documentary presentation by way of payment or delivery of the item specified in the undertaking;

**"Letters Patent"** means a letter patent and which is analogous to a charter, in respect of official grants, titles, laws, rights or monopolies, and in respect of honour, including an incipit, a datum and a seal;

**"Lexica Dei Divinus"** , also **"Dictionary of the Divine Creator and Maker"** , means a formal lexicon (vocabulary) and a collection of meanings of key terms and phrases used in the Estate-Family;

**"Liability"** means an obligation, duty or responsibility of one person to another in the context of the life of our Estate, trust or subsidiary of our Estate;

**"Charge"** means a fee or interest in goods to secure the payment of a debt or the performance of an obligation, but this term does not include a security interest;

**"Life"** , also **"elements and properties of life"** , - the zero point " I " the beginning of everything (past / present / future - mind / intellect / memory),  
- the following smallest particles are endowed with (past / present / future - mind / intellect / memory), in the process of awakening - a connection with the zero point, with the subsequent emergence of an idea / thought, these particles evolve thanks to the rules that they created and set for the construction of the absolute, -  
the following smallest particles of the absolute are endowed with (past / present / future - mind / intellect / memory), in the process of awakening - a connection with the zero point, with the subsequent emergence of an idea / thought, these particles evolve thanks to the rules that they

created and set for the construction of universes,

- the following smallest particles of the universe are endowed with (past / present / future - mind/intellect/memory), in the process of awakening-connection with the zero point, with the subsequent emergence of an idea/thought, these particles evolve thanks to the rules that they created and set for the construction of galaxies.
- the next smallest particles of galaxies are endowed with (past/present/future-mind/intellect/memory), in the process of awakening-connection with the zero point, with the subsequent emergence of an idea/thought, these particles evolve thanks to the rules that they created and set for the construction of solar and other systems .
- the next smallest particles of solar and other systems are endowed with (past/present/future-mind/intellect/memory), in the process of awakening-connection with the zero point, with the subsequent emergence of an idea/thought, these particles evolve thanks to the rules that they created and set for the construction of solar objects known as planets, satellites, asteroids, etc.
- the following smallest particles of the planet are endowed with (past/present/future-mind/intellect/memory), in the process of awakening-connection with the zero point, with the subsequent emergence of an idea/thought, these particles evolve thanks to the rules that they created and set for the construction of everything that is on the planet known as water, earth, grass, trees, sky, stones, animals, etc., each of these objects is someone's world with its own rules for existence.

**"Self-conscious species of a higher order"** - representing: tribe, civilization, Empire, Global, Interplanetary and Galactic levels, possessing at least conscious thinking, being a unit of collective immortal consciousness;

**"Logic"** means the principles and rules that allow us to draw conclusions and reason consistently. Logic can vary, depending on the initial knowledge on which the rules and principles are built;

**"Lord"** means the person who has absolute power over the estate;

**"Lot"** means a parcel or a single item which is the subject of a separate sale or delivery, whether or not it is sufficient to perform the contract;

**"Maker"** means the person who signs or is identified in the document as the person making the obligation;

**"Man"** and **"Woman"** mean Reason;

**"Elders"** means Ancestors;

**"Estate-Family"** means the seat of power of the Estate-Family;

**"Great Rolls"** means the key records of the Household kept in the Chancery, including tenants and grants, the inflow and outflow of property, funds, and records of settlements of disputes and crimes;

**"Meaning ,"** also **"sense ,"** means intentions or purposes.

**"Member"** means one (1) of all the Gods and Goddesses and the souls, spirits and other life forms that make up the unique immortal collective mind, or one (1) of all the souls, spirits and

life forms that make up the unique immortal collective consciousness, or one (1) of all the life forms that make up the unique immortal collective awareness.

**"Businessman"** means a person who deals in goods of that kind or who otherwise considers himself by occupation to have knowledge or skill specific to the business or goods involved in the transaction or to whom such knowledge or skill may be required by that person's work as an agent, broker or other intermediary who considers himself by occupation to have knowledge or skill;

**"Mind"** means certain created systems, properties and functional states of higher order consciousness of a Self-conscious biological life form as distinct from the physical and biological processes in its flesh. Since the mind creates and determines certain systems, properties and functional states of consciousness, the term mind includes the term "consciousness" and "awareness". The three (3) forms of thinking of the mind - conscious thinking, conscious thinking, intelligent thinking are also known as the lower mind, higher mind and Divine mind:

- a. **The lower mind** , also known as the "lower self," is the physically limited mind derived from the physical apparatus that produces the mind, such as the biological brain. When such an organ dies, so does the lower mind, equivalent to a unique collective awareness;
- b. **The Higher Mind** , also known as the "Higher Self," is a non-physical mind derived from the lower mind as well as the Divine Mind, which is not limited to a physical location but chooses to obey the rules of universal laws as if it were limited to a certain boundary. When the lower mind dies, the Higher Mind continues to exist, equivalent to a unique collective consciousness;
- c. **Divine Mind** , also known as the "Divine Self", is a non-physical mind equivalent to a unique collective mind;

**"Minister-General"** means the Prime Minister of any State;

**"Minor"** means an unemancipated (describes the state or group of people who have not achieved emancipation, that is, freedom from restrictions, dependencies, or oppression.) natural person who has not attained the age of eighteen (18) years;

**"Model of existence"** - the Vorobyov Family Estate;

**"Money"** means a medium of exchange currently authorized or accepted by our country or by a foreign government. The term includes a monetary unit of account established by an intergovernmental organization or agreement between two (2) or more countries;

**"Morality"** - The Vorobyov Family Estate;

**"Mortgage"** means any conveyance, agreement or arrangement in which property is encumbered or used as security;

**"Name"** - in the Roman system means an entry in a book of accounts;  
- we define a name only as a legal identifier;

**"Nature"** means Natural Law/Natural Law;



**"Natural Law"** means the law that determines the operation of the will and power of the Divine Creator and Maker according to the Astrum Iuris Divini Canonum, through its existence in the form of matter and physical rules. Natural laws determine the functioning and existence of the physical Universe, and it can be said that all valid positive laws are derivatives of natural laws;

**"Person"** means the legal fiction of man or woman in Roman law as a perverted and false attempt to claim that the fiction of personality is part of Natural Law;

**"Negotiable Instrument"** means a form of deed creating a temporary Trust based on an unconditional promise or order to pay a fixed sum of money with interest or other charges described in the covenant or order, which complies with the three (3) essential elements of form:

1. An unconditional promise or order to pay a fixed sum of money, with or without interest or other charges, must be set forth in writing in the promise or order;
2. A negotiable instrument does not contain any other obligation or order on the part of the person promising or ordering payment to do anything in addition to the payment of money, except for specific guarantees, subsidies, interim measures or waivers in relation to security for payment;
3. A negotiable instrument must be payable to bearer or to order when it is issued or first comes into the possession of the holder;

**"Non-Resident Deceased"** means a deceased person who was domiciled in another jurisdiction at the time of his or her death;

**"Concept"** means any actual form ascribed to an object or concept that is neither a member of the species Homo Sapien nor another life form of a higher order possessing a civilized culture of goodness;

**"Notice"** means a type of notice and a procedural service by which a party is informed of any formal legal matter that may affect certain rights, duties or obligations, as well as the form of document used to communicate such facts. The main types of notice are:

- public (legal),
- factual,
- implied
- constructive;

- a. **Public notice** is a type of notice and process by which specific information relating to a formal legal matter is published in a local, regional, national or international publication having the status of a newspaper and therefore physically located on a site that is reasonably expected to be visible to the person;

Posted or mailed notice is a type of notice and process by which specific information relating to a formal legal matter is personally addressed to a party and sent by certified mail, email, fax, text message or other recorded and verifiable means of transmission;

- b. **Actual service** is a type of notice and service of process in which specific information relating to a formal legal matter is set forth in a document and then physically delivered to a party or his representative with proof and acknowledgement of such service recorded as evidence;

- c. **Implied notice** - also known as tacit notice, is a type of notice inferred from facts that a person could reasonably have known and that would have caused the person to take reasonable steps to obtain further information on a particular legal issue. It is notice given or imputed to a party based on his knowledge surrounding the underlying fact;
- d. **Constructive notice** is a type of notice inferred from the facts that a person who is unable to state his position with actual notice may be reasonably compelled to receive notice if actual notice was not obtainable and a minimum number of attempts were made at both published (mailed) notice and public notice;

**"Oath"** means a solemn appeal to the Divine Creator by means of an invocation in the presence of at least two (2) witnesses who attest to the truth of a statement or the binding nature of a promise;

**"Pledge of Allegiance"** means a sacred oath;

**"Oath of office"** means a sacred oath;

**"Sacred oath"** means the oath of allegiance and the oath of office as it relates to office;

**"Obedience"** means the quality and character of honoring and observing the commandments, orders, intentions and instructions of the Divine will through the laws of the Estate-Family;

**"Object"** means something that can be observed as true by two (2) or more separate observers and whose existence is independent of the methods by which the observers name and classify it;

**"Office"** means a position of trust granted by authority;

**"Official Notice"** means a notice;

**"Formal Organization"** means a corporation, commercial Trust, Estate, Trust, partnership, joint venture, association, government or governmental subdivision or agency, or any other legal or commercial entity;

**"Official international recognition"** means official recognition by an existing foreign state or by an entity which itself has recognition by other foreign states such that all foreign states recognize the existence of our Family Estate or a document derived from it;

**"Offer"** means that one (1) party to a contract or agreement presents some valuable consideration which the other party accepts or rejects on specified terms. In the absence of a valid offer, the contract or agreement cannot exist;

**"Officer"** means a duly appointed General Executor, trustee or agent of our property;

**"Instruction"** means a written order for the payment of money signed by the person giving the instruction. An instruction may be addressed to any person, including the person giving the instruction, or to one (1) or more persons jointly or alternatively, but not successively. An instruction to pay is not an order unless the person authorized to pay is also informed of the payment;

**"Organization"** means a social unit of people systematically structured and managed to meet needs or achieve collective goals on a continuing basis;

**"Original Rights"** means those rights (untainted, irrevocable, inalienable gifts) that the Divine Creator and Maker has bestowed upon every member of the Homo Sapien species on planet Earth;

**"Our"** means the possessory or prescriptive right of **"Us"** ;

**"We ourselves"** means Ours;

**"The Testament of the Vorobiev Family"** means the highest of all testaments and agreements, the highest of all contracts, the highest act of trust and ownership, the highest source of all powers and rights and the highest object of value, consisting of four (4) main sections, which are Exordium (preamble), Recitatum (recitation), Decretum (agreement) and Obsignatum (acceptance);

**"Parent"** is a human position established by a biological Self-conscious life form of a higher order;

**"Party"** is a human form (a fictional form activated by a higher order biological life form) participating in an activity.

**"Patent"** means, as we understand patents today, "a set of exclusive rights granted by the state to the inventor or successor in title for a specified period of time in exchange for the disclosure (provision) of the invention";

**"Payer"** means a person authorised or required by law or regulation to make payments;

**"Peccatum Originale"** , also **"Original Sin"** , refers to the false teaching of the 16th century that just as the inheritance of property is transmitted from one generation to the next, due to the sins of our ancestors (Adam and Eve) all infants are born with an hereditary blemish (stain or debt) which disqualifies them and their heirs from claiming all the rights of enjoyment originally promised, granted and accorded to all men and women by the Divine Creator and Maker. Moreover, the sins of our ancestors (Adam and Eve) were so grave against the Divine Creator and Maker that each generation is doomed (cursed) to one mortal life of pain and suffering in the world of purgatory (In Mundi), which is the general absence of the active presence of the Divine Creator and Maker until the end of days. Finally, the sins of our ancestors (Adam and Eve) resulted in all infants being born deprived of holiness and grace, so their souls were subject to moral doom and to eternity in hell, unless their souls were saved through baptism for the sake of the Roman cult;

**"People"** means Self-conscious biological life forms of the highest order, as well as predecessors, descendants, heirs, the earth;

**"Performance"** means the act itself or its completion as defined and required by any form of consent;

**"Person"** means a legal fiction or any actual form defined in law created by a biological Self-aware life form of a higher order and evidenced by its functionality and unique existence, including, but not limited to, a Divine Person, a true person, a supreme person, an individual, a corporation, a business Trust, an estate, a Trust, a partnership, a limited liability company, an association, a joint venture, a government, a subdivision of a government, an agency, an instrumentality, or a public corporation;

**"Personal Property"** , also **"Private Property"** , also **"Moveable Property"** - means the preferential right of use within our Estate-Family of any movable rights, anything that is not legally attached to the Land, even if it is the fruits of the land, especially anything that can be used for sale. Personal Property also includes intangible personal property, including, but not limited to, negotiable instruments, securities, services and legal rights not directly attached to or not being real property;

**"Personal Representative"** includes an executing administrator, a successor personal representative, a special administrator and persons performing substantially the same functions in accordance with their status. "General Personal Representative" does not include a special administrator;

**"Petition"** means a written request to the court for an order, after notice;

**"Possession"** is the intentional act and fact of having possession, use, or effective control over a Form. Possession differs from ownership in that the person who possesses a Form cannot have a legal claim or title;

**"Positive Law"** means the laws that are made by men and women by virtue of the power delegated to them in accordance with the Astrum Iuris Divini Canonum for the governance of society. Since Positive Law ultimately pertains to physical objects and living beings, it may be said that all valid Positive Laws are derived from Natural Law;

**"A posteriors"** means Heir;

**"Poverty"** means the quality and character of lack of personal ownership of property, especially personal belongings. It does not necessarily mean lack of use of certain property, a poor quality of life, or lack of sufficient food or shelter. Instead, poverty is a voluntary asceticism and renunciation of claims to personal ownership of property in deference to the fact that such property is claimed, owned, and administered by other entities, such as our Estate-Rod;

**"Present Value"** means the aggregate, as of a specified date, of one (1) or more amounts payable in the future, discounted to a specified date using either the rate of interest specified by the parties, unless such rate is manifestly unreasonable at the time of the transaction, or, if the rate of interest is not so specified, a commercially reasonable rate having regard to the facts and circumstances at the time of the transaction;

**"Principal Debtor"** means the receiving party or any other party to the instrument against whom the secondary debtor has a right of recourse;

**"Probate"** also **"probate hearing"** means a probate proceeding in which one (1) or more claims to an estate are proved. A probate hearing shall not be scheduled if there is a clear and unmistakable public record of the existence of a valid will;

**"Attorney General"** means the most senior legal adviser and revenue collector for our estate;

**"Action"** means an action at law and an action in equity;

**"Promise"** means a written undertaking to pay money, signed by the person obligated to pay. An acknowledgment of an obligation by a debtor does not constitute a promise unless the debtor also undertakes to pay the obligation;

**"Property"** means any right of use expressed in trust. Therefore, property is equivalent to the use of an object or concept. Property may be classified either as real property or as personal property, or as any interest therein and any right that may be the subject of ownership of our property;

**"Defendant"** means a minor or other individual in respect of whom a guardian has been appointed or in respect of whom another protective order has been issued;

**"Public Notice"** means a Notice or Newspaper;

**"Public record"** means information that is entered into a register and can be retrieved by means of a tangible medium that is open to the public;

**"Purchase"** means acquisition by sale to another, lease, discount, negotiation, mortgage, pledge, security interest, release or transfer, gift or any other voluntary transaction creating an interest in property.

**"Buyer"** means the person who acquires by purchase;

**"Reasonable being"** means Enlightened mind;

**"Reality"** means a fictitious model of existence, built on rules, form and meaning, providing a degree of certainty and reproducibility necessary for the functioning of Positive Law. Neither reality nor absolute truth exists according to Natural or Divine, Spiritual law, since the Universe of a unique collective Mind depends on the existence of a unique collective consciousness and a unique collective awareness, paradox and relativity. Reality allows for a functional model of existence that excludes the existence of paradox and relativity. Thus, in the fictitious universe of reality, in accordance with all Positive laws, the concept of truth exists and the certainty of logic and reason can be applied. Reality allows for the recognition and existence of certain concepts considered valid according to Positive Law, which do not exist according to Natural or Divine, Spiritual law. Such concepts as freedom, justice and morality do not exist within the framework of Natural Law, but are an integral part of the optimal function of a civilized society under Positive Law;

**"Real Estate"** also **"real property"** means the right of first enjoyment within our Estate of any right to the Land, the fruits of the Land, anything legally attached to the Land and any improvements made thereon, including but not limited to such things as Buildings, dwellings, walls, dams, mines, roads, pipes, machines, canals;

**"Cause"** means the cause of an event and any formal system of thought that uses cognitive faculties to understand, evaluate, infer, or imply such causes. Everything in the universe can be observed and related according to reason. Therefore, the absence of reason is the absence of cause.

**"Statement of Terms"** means these terms;

**"Record"** means information that is recorded on a tangible medium or stored on an electronic or other medium and can be retrieved in a perceptible form;

**"Receipt"** means a written confirmation by the seller of payment for goods, payment of a debt or receipt of property from another person;

**"Receipt of goods"** , also **"receipt"** , means physical possession of the goods and the corresponding receipt. A valid receipt for the goods does not exist unless both the goods and a proper receipt are presented;

**"Register"** means a book in which records are accurately recorded of aspects of the Form that are of material importance;

**"Registered security"** means a certified security that gives the owner the rights defined in accordance with the security, provided that it is the same person indicated in the register that coincides with the identification of the security. The transfer of a registered security is carried out by making changes to the register;

**"Registrar"** means the officer of our estate appointed as agent, general executor and guardian and to perform the functions of registrar;

**"Relativity"** means that certain rules for characterizing or properties of objects, phenomena or processes are not absolute, but depend on the context, point of view or conditions in which they are considered.

**"Remedy"** means any procedural right that an aggrieved party may rely on, whether or not he or she has recourse to a court;

**"Respondent"** means the individual in respect of whom a guardian, conservator or other protective order is sought from the executor general and guardian or their duly appointed agent;

**"Representative"** means a person authorized to act on behalf of another person, including an agent, an officer of a corporation or association, and a trustee, executor, or administrator of property;

**"Revelation"** means the formal disclosure of the past, present or future intention and will of the Divine Creator and Maker;

**"To render"** , also **"to be rendered,"** means to re-endow and to possess property or rights acquired a second time by the party from whom it was taken;

**"Right"** , also **"right to use"** , means a certain power, capacity, claim, privilege, use, benefit, or authority, inherited in a form, person, or thing, which may also be defined as property. Therefore, right also means an interest or ownership in an object of property, or a just and legal claim to possess, use, or enjoy it, or to convey or bestow such property;

**"Rule of Law"** means AstrumIurisDiviniCanonum;

**"Security"** means any banknote, stock, treasury stock, bond, debenture, certificate of indebtedness, certificate of interest in or participation in any oil, gas or mineral title or lease or in payments not made under such title or lease, security trust certificate, transferable share, voting trust certificate or, generally, any interest or instrument commonly known as a security, or any certificate of interest or participation, any time or interim certificate, receipt or certificate of deposit, or any warrant or right to subscribe for or purchase any of the foregoing;

**"Security Interest"** means an interest in personal property or fixtures that secures the payment or performance of an obligation. A security interest includes any interest of the shipper and the purchaser in an invoice, chattel, intangible payment, or note in the transaction. A security interest



does not include a special property interest of the purchaser of goods in attributing those goods to a contract of sale. The right of the seller or lessor of goods to retain or acquire possession of the goods is not a security interest, but the seller or lessor may also acquire a security interest. The retention or reservation of title by the seller of the goods, whether or not shipped or delivered to the purchaser, is substantially limited by the clause constituting a security interest;

**"Send"** means, in connection with a letter, record or notice, to deposit by mail or deliver for transmission by any other ordinary medium, postage paid or cost of transmission provided and properly addressed, and in the case of a document, to send to the address stated in it or otherwise agreed upon or, if there is no such address, to any address reasonable in the circumstances, or by any other means to ensure receipt of any record or notice within the time within which it would have been received if properly sent;

**"Seller"** also **"seller of goods"** - means a person who sells or contracts for the sale of goods;

**"Services"** means the Goods;

**"Settlement"** means payment by cash, clearing house settlement, payment or credit, money order or other agreed method. Settlement may be either provisional or final;

**"Settlement"** means, as used herein, the entire process of managing, distributing and closing the entire estate;

**"Signed"** includes the use of any symbol affixed or adopted with the genuine intent to accept or approve the writing;

**"Society"** means Self-conscious biological life forms of a higher order, united by mutual consent to deliberate, determine, and act together toward some common goal;

**"Sovereign"** means "to rule and reign as a savior";

**"Space-time"** means the time of the Vorobyov family;

**"Special Administrator"** means a personal representative;

**"Species"** means a group of living organisms consisting of similar individuals capable of exchanging genes or interbreeding;

**"Standing"** means the admission of evidence that a party is permitted to appear in connection with any matter before a competent court and any related bodies to interact in the proceedings. Standing is established by a party proving that they are present as one (1) of three (3) types, being an interested party, an authorized party or an amicable party:

- a. **An interested party** is a person who has brought a formal claim against our estate, the Trust or a subsidiary Trust and whose claim is the subject of litigation;
- b. **An authorized party** is a person who holds signed and sealed warrants or letters from the general executor or duly appointed attorney of our Estate-Rod, granting them judicial office to hear and supervise a legal matter in court;
- c. **A friendly party** is a person or Self-aware life form of a higher order possessing separate authority from a foreign state which, through a direct or indirect contract with our estate, Trust or subsidiary, places them as equivalent to being an authorized party.

**"State"** means any higher class, according to Roman (Western) law, recognized as possessing political and topographic territorial boundaries and sovereign jurisdiction within the framework of a parliamentary and governmental apparatus;

**"Sublease"** means the lease of goods, the right of possession and use of which has been acquired by the lessor as lessee under an existing lease;

**"Auxiliary"** means subordinate or secondary in importance;

**"Successor Personal Representative"** means a personal representative, other than a special administrator, who is appointed to replace a previously appointed personal representative;

**"Assignee"** , also **"assignees"** , means a person other than the creditor who has title to the property or certain rights defined herein;

**"Sufficiency"** means the relative weight and equality of what is offered by one (1) party compared to what is given as acceptance in return, so that such exchange cannot be argued to be unequal or unfair. If a contract or agreement is manifestly insufficient, it ceases to have any legal or enforceable effect;

**"Supreme corporate governance body"** means "Corporate Governance Body";

"Supreme Trust" means a form of living Trust, validly registered in the Grand Register of the Estate, containing real property, also known as estate, which is the supreme form of usufruct rights therein and administered in accordance with the sacred Testament of the Estate. A Superior Trust is formed when the true person grants and conveys certain usufruct rights, known as real property or estate, to a superior Trust, thereby creating the trust of the superior Trust, also known as the superior body corporate, also known as the superior, having legal personality. The superior body of which the superior is a member is always the executor and administrator, the true person as trustee and the superior as beneficiary;

**"Trust High Number"** means the alphanumeric unique numeric number of the symbols of the actual Trust-Estate as a valid entry in the great register of that particular Trust-Estate as a Member thereof;

**"Supplier"** means the person from whom the lessor purchases or leases the goods to be leased under a finance lease agreement;

**"Surrender"** is a priority obligation and merger without consent, especially with respect to Copyright;

**"Surety"** - consists of a surety or other secondary debtor;

**"Survival"** means that a Self-aware higher-order biological life form has not been preceded by any event, including the death of another Self-aware higher-order biological life form, and is not considered to be preceded by an event as defined herein. The term includes derivatives such as "survives," "survived," and "survivor";

**"Terms"** - means that any existing terms and the meaning of key words are clearly stated in plain language and that all parties have had a reasonable time to read and consider them. If the

terms do not exist, are misleading or grossly unclear, the contract or agreement ceases to have any legal or enforceable effect;

**"Rescission"** - occurs when either party, by virtue of authority created by agreement or law, terminates a contract otherwise than for breach. On rescission, all obligations still due on both sides are discharged and any right based on previous breach or performance is preserved;

**"Will"** means the condition or circumstances of making a will, leaving a valid will, or making a testamentary disposition;

**"Testament procedure"** means the procedure of making a testament or pronouncing a will when there is no proclaimed will or recognized public record of the existence of a valid will, and "testament" means the perpetuation of the will of a man or woman in the person of a person;

**"Testator"** means one who makes a Will and Testament in respect of our estate and therefore one who makes this instrument;

**"Thing"** means a temporary form existing within the framework of a legal issue, where the status of the form is the subject of a dispute, as a person, an animal or a concept. The form of a thing cannot exist outside the competent forum. Therefore, all forms of things are reduced either to the form of an animal or to the form of a concept;

**"This"** means this document;

**"Title"** and **"title"** are both an actual entry or record in the register of the Trust's assets and evidence or notice of such entry and therefore a claim to title. The word "title" is derived from the Latin "titulus" meaning "an inscription, label, and notice (of entry) in a tabulae" and the Latin word "tabulae" literally means register. It was most often used in the context of a register of slaves. The Latin word for registrar is "tabularius";

**"Contract"** means a binding agreement under international law between our Estate-Family and foreign states, entities, self-conscious life forms or bodies, clearly expressing the will and intention of the parties;

**"Treasurer"** means the person and official who is entrusted with the funds and income of our Estate-Family;

**"True Trust"** means a form of Trust containing Divine property, known as Divine Usage Rights, or Divinity, which is legally registered in the Grand Register and public records of the Estate. A True Trust may be for a man or woman, a so-called "True Person Trust," a True Location Trust containing Divine Usage Rights in the promised land, or an Aggregate Trust such as a Universal True Trust, a Global True Trust, or a Civil True Trust. By definition, Divinity or Divine Usage Rights cannot exist without a Divine Trust. Therefore, no valid True Trust can exist unless it is created from a valid Divine Trust. A true trust is formed when a Divine Person grants certain Divine rights of use, known as divinity, into the trust of a true person, creating the trust basis of a true Trust, also known as a true corporate basis, also known as a true person possessing legal personality.

The mind of a Self-aware life form of a higher order is always the principal executor and custodian of the entire Self-aware life form of a higher order.

The entire Self-aware life form of a higher order, also known as living flesh, also known as the

living body of an organic life form of a higher order, is always a trustee with the true person as the beneficiary;

**"True Trust Number"** means an alphanumeric unique key, as a valid numerical entry in the Great Register, as possessing divinity;

**"Trust"** includes an express trust, private or charitable, with various additional parts, wherever created. The term also includes a trust created or established by a court order or under which the trust is to be administered as an express trust;

**"Trust Body"** means a Corporate Body;

**"Trustee (attorney)"** - includes an original, additional or successor trustee, whether appointed by or without a court order;

**"Principal"** means the one who creates a trust in relation to our Estate-Family;

**"Unauthorized signature"** means a signature made without actual, implied, or apparent authority. This term includes forgery of documents;

**"Unilateral consensus"** is an agreement between the minds of two (2) or more parties regarding one (1) or more actions concerning certain property or rights affecting only the lower mind, also known as the lower self or simply the flesh by implied consent;

**"Unique Numeric Key"** means a twenty-two (22) character numeric or alphanumeric sequence representing a unique identifier of a record in uppercase;

**"Our"** means "we";

**"Valuable consideration"** means the total property or rights that are the subject matter of a contract or agreement. In the absence of any valuable consideration, a contract or agreement ceases to have any legal or enforceable force;

**"Volition"** means a conscious choice or decision, supporting a specific intention, which leads to a motive in the connection between mental impulses and physical actions of some form of intelligence. Volition is therefore equivalent to the concept of "free will";

**"Warehouse receipt"** means a document issued by a person or enterprise engaged in the storage of goods;

**"We"** means the Holy Spirit or the Divine Immortal Spirit, expressed in trust in the competent enlightened mind as the supreme Lord in trust over the limited flesh and dedicated individuals known as Sergei Nikolaevich of the Vorobyov family;

**"Warrant"** means a form of order, signed and given by the general executor or a duly appointed attorney-in-fact to one or more agents, directing the performance of certain acts while providing the agent(s) with limited immunity from liability for any damage or wrong that may arise from the performance of the acts directed;

**"Ward"** means the natural person for whom a guardian has been appointed and all children, minors, protected persons so named, stated or implied to have such status under this instrument and therefore lawfully under the authority and responsibility of the General Executor as General Guardian;

**"Will"** means the perpetuation and expression of the will of a person or persons related to the will (testament) of a man and a woman in the person of a person;

**"Will and Testament"** means this document;

**"Testament"** - The term "testament" was first coined at a Jesuit college in England in the late 16th century, and was later presented in the guise of Shakespeare's portfolio as part of the introduction to the world's first system of mind control, which eventually replaced physical slavery with (voluntary) mind slavery. The word "testament" comes from two Latin words: "testa" (or "testari"), which means "to testify, give evidence/demonstration; to communicate, make known, publish, announce; to be confirmed/attested, declared; to make a will; to call to witness", and "mentis", which means "mind". Thus, the true original meaning of the word "testament" is "to testify, give evidence, or make a will of the mind";

**"Order"** means a written order;

- the right to issue orders is granted to the sovereign;

**"Letter"** includes printed, typewritten or any other information (data) in material form. Written has a corresponding (related) meaning.
