Since Natural Laws determine the functioning and existence of the physical universe, it can be said that all valid Positive laws are derived from Natural Rights.
- Natural law cannot be written or created, it can only be discovered. Divine law can neither be written nor created, but only prescribed by Divine Revelation through the Spirit, without contradicting Natural Law.
- Positive law is the laws that are passed by men and women through proper authority to govern society. Since Positive Law ultimately refers to physical objects and living beings, it can be said that all valid Positive rights derive from Natural Law. Positive law cannot cancel, suspend, or change Natural Law. Positive or Natural law also cannot cancel, suspend, or modify Divine or Spiritual Law. Therefore, the supreme right of all rights is Divine Law, then Spiritual Law, then Natural Law, then Positive Law.
