4. Executive power in this document belongs to the Government, which consists of one Executive General and such number of administrators as it deems necessary to ensure the fulfillment of the duties of the executive administration.

- The Executive General is vested with the right and authority to appoint, monitor and terminate the activities of Commissions for swearing allegiance and swearing in the ministry of one or more authorized agents (servants) who assist in the implementation of his administrative orders on behalf of the Estate-Clan.

Thus, according to Roman Law, Western Law and Higher International Law, the current Apostolic Mendicant Minister is outside the jurisdiction of any legal entity, State or associated legal entity.
- By definition, the Apostolic Mendicant Minister, as an Authorized Representative, informs about his status and procedural legal capacity through auricular confession (pronunciation aloud), and not through any written presentation. In addition, the Apostolic Mendicant Minister communicates his status through the postulate "I am from this World, but not from this World."
